

Summary of Day 7:Challenges of securing women participation in forestry and climate action and Prospects

The challenge

- Women represent a high percentage of the poor
- In rural areas, they depend on natural resources for their livelihood, health needs, energy for cooking and heating, as well as for food security.
- Rural women are involved in agriculture but lack access to their own land which is major resource for climate action.
- There is low participation of women in decision-making on forest and climate change.





Discussions

- What is preventing women from participating in forestry and climate change action?
 - Systems (male dominancy sector)
 - Cultural barriers (practices that prevent women from speaking in public)
 - Security of women (from harm)
 - Low levels of education and capacity
 - Confidence
 - Interpretation of provisions in the law
 - Access to information
 - Access to resources





What needs to be done

- Society has a high expectation for women in positions
- Such women therefore need
 - To conduct research on their fields
 - Be competent
 - Make input at the decision-making spaces but not just be counted
 - Be visible and intentional
- Empowered women should mentor and empower others especially young ones.
- Promote education of rural people especially women





What needs to be done

- Addressing poverty since economic empowerment will enhance participation of women.
- Develop and implement Policy.
- Men to support women for holistic development.
- Promote women's access to resources like land.
- We need to break societal barriers and transform society.





What are the men, women, youth doing to support each other in the decision-making process?

- Women needs to build their capacity and confidence level.
- Women should make their voice heard when necessary
- Participate fully in decision making when giving the opportunity
- Sensitization of issues to rural women to fully participate and maximize their potential
